NOTICE FOR EARLY MARKET ENGAGEMENT

1. The Government of Haryana through Government of India has applied for financing from **The World Bank** towards the cost of the **Gurugram Metro Rail Project – Phase-1** of Sustainable Multimodal and Resilient Transport for Haryana.
2. GMRL (Gurugram Metro Rail Limited) is inviting E-Bids from prospective bidders for the **work of Viaduct and Stations including PEB, Architectural finishing works** very soon. The World Bank procurement regulations for IPF borrowers and Standard Procurement Document specifies **the application of Rated Criteria including their mandatory weightings** for bid evaluation purposes w.e.f. March'2025 onwards. The Technical and Financial Scores will be considered to determine the **Most Advantageous Bid**, provided the Bidder is qualified to perform the Contract.
3. The **E-Procurement Notice** is planned to be issued in January'2026. GMRL is conducting **Early Market Engagement** to:
 - Prime the Market, so they are ready to respond to the opportunity in advance;
 - Improve the understanding of the Evaluation and Qualification Criteria including Rated Criteria on QCBS basis, among the prospective bidders;
 - Communicate needs or requirements to the bidders and openly/transparently discuss possible solutions;
 - Identify potential risks early in the project cycle;
 - Feedback on the proposed procurement approach and invite suggestions for improvements;
4. **Early Market Engagement Meeting is planned on 29.12.2025 at 11.00hrs. to 12.00hrs. in Physical and Virtual Mode.**
